## **Direct Support Professional Appreciation Week Celebrated**

September 12-18, 2021 marked Direct Support Professional Appreciation week. At Mount Aloysius, we celebrated our DSPs in a variety of ways including gift card raffles and snacks. A Direct Support Professional (DSP) is someone who works directly with individuals with intellectual or developmental disabilities. A DSP provides support with everyday tasks such as cleaning, hygiene, toileting, dining, shopping, and attending appointments. Sometimes when people think of the services Mount Aloysius provides, they think of caregivers. While a caregiver may be incredible in the role, there is a difference between what a caregiver does and the work of a Direct Support Professional. A caregiver will do things for someone (e.g. pick out groceries). In contrast, a DSP will work with someone to enable them to do things independently (e.g. help them to pick out their own groceries). The next time you visit Mount Aloysius be sure to thank the DSP who is helping to care for your loved one. We could not operate without each and everyone of them! Thank you DSPs for everything you do for the men of Mount Aloysius. You not only provide quality care for the men but you also provide peace of mind for families who are unable to care for their loved one in their home.

#### Mount Aloysius Board of Director's & CEO Update Submitted by Justin Gall, CEO

Fall has quickly descended upon us, and it is hard to believe we are already preparing for the holidays and the beginning of a new year. At Mount Aloysius, we embrace the change of seasons and get excited to reflect on all we have accomplished from one quarter to the next. The past three months have been busy with the implementation of our Strategic Plan placing emphasis on continuous quality improvement and taking steps towards service array expansion.

Although we hoped to be further along, the current state of the national pandemic has thrown some obstacles our way, slowing the process. Because we have not been able to move forward as quickly as we would like, we have taken this time to gain a richer understanding of and a deeper commitment to refining our core value of providing exceptional care to all individuals with developmental disabilities. We are working with our teams and learning how to navigate our new environment while doing more with less. We strive and take pride in providing exceptional care. For some, "good" may be good enough, but we want more, we want greatness all the time. We want Mount Aloysius to be remembered for what was accomplished and for our passion for excellence and exceptional care to all individuals.

Over the last several months, our primary focus has been on staff development. Mount Aloysius has been navigating the current statewide staffing shortage including shortages with Nurses and Direct Service Professionals. We have spent time with our staff providing training and have been creative on ways to retain our current staff and recruit new professionals to our field. Most recently, we provided staff with a 10% thank you increase in addition to an increase to the starting wage for all new employees. We find it important to take care of those who take care of your loved ones along with encouraging others to join our team. We continue to ask for your patience during this challenging time and be assured, the health and safety of our residents continues to be our top priority.

Finally, President Biden has announced a six-prong plan on COVID-19 entitled "Path Out of the Pandemic." The plan focuses on mandated vaccination to include health care facilities and employers with 100+ employees. This plan is an aggressive approach to vaccinate people, however there are many holes and questions that have not been answered within this order. The exact scope of the expanded health care vaccine mandate continues to be vague, and our status remains unclear. Once more information is available, we will provide you with an update.

I would like to end by thanking all of you again for your continued support, understanding and trust. As always, please do not hesitate to reach out to myself, Shannon or Kim with any questions, suggestions, or comments. We welcome your input.





### **Travel Reminders**



With the approach of the holiday season and any time throughout the year, please remember to communicate

travel plans to Ben Brannon, Social Services Coordinator, or Kasey Penrod, Social Services Assistant, at least one week in advance, if we will need to transport a resident in any way, i.e. airport, bus station, meeting place, etc. This will enable us to arrange staffing, prepare doctor letters, medication, and any other items needed. We need at least a 3 to 5 day notice in order for Nursing to make sure they have enough medication on hand.

We also ask that you provide at least one business day notice if you plan to visit your loved one at the facility so necessary arrangements can be made.

All travel arrangements and visits to GLOW House should also be arranged with Ben or Kasey. It is important to remember that there are only two staff working at GLOW House. We will need to have advance notice if we will need to transport the resident in any way.

The following are planned airport/travel dates for Thanksgiving: November 23<sup>rd</sup>, 24<sup>th</sup>, 26<sup>th</sup>, and 29<sup>th</sup>. Airport/Travel Days for the Christmas holiday include: December 21<sup>st</sup>, 22<sup>nd</sup>, 23<sup>rd</sup>, 27<sup>th</sup>, 28<sup>th</sup>, and January 3<sup>rd</sup>.

If there is inclement weather, Mount Aloysius will not transport residents. We cannot endanger the lives of residents and staff by driving during inclement weather. Please keep in mind that if there is inclement weather, travel arrangements may need delayed until the roads are cleared or until another day.

We are asking that any families who are planning to have their family members travel by airplane this holiday season, to make arrangements on the airport travel days. This way a whole group can travel to the airport, and we will not have to make various trips throughout the month.
